OFFER TO PLAY

This is the official **OFFER TO PLAY** for ECFH Club; you will be expected to make every effort to comply with reasonable expectations of the East Coast Field Hockey Club based on the level of commitment you decide to engage. Players can also change their Level of participation as their time requirements change.

Whatever level of participation the ECFH Club player chooses, Level 1, 2 or 3; the following will apply:

1. Commit to a one-year participation contract on one of East Coast Field Hockey Club's teams September 1, 2011 thru August 31, 2012. Players playing with ECFH will have ample opportunity to play hockey with their school teams. Players in the Elite Level Program will need to attend key ECFH events, in the event there is a conflict between a high school event and a Club event, excluding the high school normal playing season where the High School Hockey program takes preference over ECFH, East Coast event will have priority. At **NO TIME** may a player be registered with two field hockey clubs, according to USA Field Hockey Rules. Players may not register with another field hockey club to attend a USA Field Hockey Sanctioned Qualifier. If a player does register with another field hockey club, without prior approval by the ECFH Director, this will result in immediate termination from the Club and membership and any fees paid to date will not be refunded.
All players will be expected to justify any cards (yellow, green, red) received during the year to a coaching committee.
2. Come to all practices where you are assigned and arrive 5 minutes prior to the start time. If unable to attend, you will contact the Training Center 717-220-0002 at least two hours before the scheduled start time. Player's attendance for week day training will be based on travel distance as players living more than 1 hour distance will be provided special consideration and their training focused to weekends. The number of training hours will be equal for local as well as out of area and out of state players. Saturdays and/or Sundays will have additional hours focused on these players who do not live locally.
3. Attend all games where assigned and arrive 45 minutes prior to the start of each game. If unable to attend, contact the Training Center at least 5 days prior to the game so that your team can be re-organized. Fees for every tournament will be paid equally by each team member independent of participation in a particular tournament.
4. Bring the mandatory equipment for each practice and game – shoes, shin guards, mouth guard, glove, stick and water bottle.
5. Dress properly to represent your Hockey Club in each local, regional, state, national or international event.
6. Realize that your playing time will depend on how dedicated and motivated you are at practice both in the Center and on your own, your discipline on and off the field and your technical and tactical skill development. An important goal is having a team of not only superior skilled players, but players highly committed to excellence on and off the pitch. Being part of East Coast Field Hockey does not mean equal playing time for everyone. You will play the amount of time you earn.
7. Indoor Season Fee, uniform and tournament fees must be paid in advance of participation.
8. Tournament Fees: Each team member will be charged and expected to pay for any tournament to which the team is assigned no matter if every player can or cannot attend. Fees will average \$60.00 per tournament and \$175.00 for Qualifiers. Exact tournament fees will be shared once tournament schedule is communicated. Estimated to be a minimum of six (6) tournaments offered during the indoor season. Listed fees do not include travel costs.
9. Work is generally not an accepted excuse for missing a scheduled game or practice.

10. You must realize that anyone coaching your team at any particular time will be coaching under the guidance of the Director of Coaching.
11. All players will be expected to justify any yellow or red cards received during the year to a coaching committee.
